




BLOOD PRESSURE THE SILENT KILLER

STANDING ORDERS

- 1. A question will be decided by a show of hands, unless a poll be demanded by the Chairman, or by 10 members entitled to vote either present in person or by proxy. No question shall be declared carried by a ballot vote unless such question has received at least two-thirds of the ballot votes cast. In a case of equality of votes, whether on a show of hands or on a poll, the Chairman shall be entitled to a second or casting vote.
- 2. During debate, speakers must go to the microphone and announce their Name, Town and Region before they address the Chair
- 3. Speakers include all Members (both voting & non voting) and students.
- 4. A member proposing or seconding a resolution must be present at the meeting.
- 5. The motion "To pass to the next business" shall take priority over all amendments, and, if carried by a majority, shall allow the meeting to proceed immediately with the next business on the Agenda.
- 6. The mover of the original motion shall have the right to reply when discussion has been closed. No new matter may be introduced or further discussion permitted before the vote is taken,
- 7. Discussion shall cease if a motion "that the question now be put" is proposed by a Member not having previously taken part in the discussion.
- 8. A Member shall speak only once in a discussion on a motion or amendment, except by permission of the Chairman, who must also allow other Members the same privilege.
- 9. All amendments shall be dealt with separately. When an amendment is proposed and seconded, discussion shall be continued to that amendment and a vote taken. If carried, the original motion is then put to the meeting in its amended form, when it is open to discussion and further amendment. If the original motion stands and discussion proceeds.
- 10. The Chairman shall have the power to adjourn the meeting or to settle points of order not otherwise dealt with in these Standing Orders.
- 11. Any Member, who has an urgent need to keep a mobile telephone switched on in the meeting, shall sit immediately adjacent to a door and leave the meeting room as soon as a call is received.

1 Accounting policies

Company information

1.1 Accounting convention

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006.

These financial statements for the year ended 31 March 2025 are the first financial statements of British Institute of Funeral Directors prepared in accordance with FRS 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland. The date of transition to FRS 102 was 1 April 2023. The reported financial position and financial performance for the previous period are not affected by the transition to FRS 102.

1.2 Stocks

EDUCATION REPORT: ANDREW FLOYD (CHAIR OF EDUCATION, REGION B)

Tutor Training: It was confirmed that three people attended an information session on 11.10.2024. Subsequently, six people have committed to registering to take the Diploma in Teaching (DIT, level 5).

This course will be predominantly held via Teams, with x4 in-person observed classes per candidate in their place of teaching, which will be completed by Andrew Floyd.

The cost will be £3,500 per candidate (negotiated down from £5,900 there is a cohort of 6, and we will be facilitating the observation aspect of the assessment). A pathway to PgCE is embedded into this course, should candidates wish to continue with their learning.

The DIT course will start on 1 November 2024, with the end-point assessment in June 2025. Tutors with an existing level 4 qualification will be known as 'BIFD Approved Tutors' and will be able to teach the Certificate in Funeral Service and present the Introduction to Funeral Service only.

Tutors with a level 5 DIT qualification will be known as 'BIFD Accredited Tutors' and will be able to teach the full suite of courses.

Revision of Textbooks: Due to the many changes that have been implemented since the last revision in 2020, the Education committee has suggested that a textbook committee be formed as a working group to make changes to the textbook, all relevant members of the education team will be approached to form the committee (of 4 or 5 people). The Education committee will be also approaching BIFD members who may be able to assist the committee with specific chapters (e.g. Scotland, Embalming, Repatriation, etc.) chapters will need be prioritised in order of importance.

Certificate in Funeral Service Cohort: Currently there are 28 candidates enrolled in the revised academic year Certificate in Funeral Service (September 2024 – February 2025).

Introduction to Funeral Service: The last Introduction course was facilitated online six months ago, we have had around 350 interested parties in this course, with the majority indicating that they would prefer to attend an online session. Andrew commented that the Institute will facilitate four of these sessions online throughout the year, and any of the approved tutors are welcome to hold in-person sessions in addition to these four webinars.

It was mentioned by having tutors personally curate these sessions enables them to build a potential relationship with those who may wish to progress onto our suite of courses.

It was agreed that a fee of £175 per candidate be charged. It was suggested that there would be a minimum number of cohorts to cover the fee for the presenter.

Margaret Dow (Past President, Region A) took to the podium to share changes to Repatriation of a deceased person to Scotland, stating that a Coroner's Interim Death Certificate would now be accepted as part of the paperwork.

Thanks were expressed to the Education team for their continuing hard work.

Why Grief Support Matters: New Research Links Prolonged Grief to Long-Term Health Risks

Grief is a universally human experience, but one which various hugely from individual to individual. A study by researchers in Denmark has found that people experiencing intense, prolonged grief after the death of a loved one are nearly twice as likely to die within ten years. The research offers compelling evidence that grief isn't just emotional, it can also have serious, long-lasting impacts on our physical and mental health.

At MuchLoved, we believe this strengthens the case for early, compassionate bereavement care and better grief education for all.



Grief That Doesn't Ease

The Danish study followed over 900 bereaved people for more than a decade who had lost their partner, parent or other family member. While many adapted well over time, a significant group showed persistent, high levels of grief symptoms.

The study found that people in this group were:

- Almost twice as likely to die within the subsequent 10-year period
- Significantly higher users of healthcare services
- More likely to take medication for depression, anxiety, or sleep problems

This isn't to say grief always leads to illness, but it underlines that when grief remains unsupported, the consequences can be profound.

Why Accessible Bereavement Support is Essential

Not everyone who struggles with grief will feel comfortable seeking professional help, and even fewer will know where to turn. Many will be unaware of all the physical symptoms that can manifest in grief.

That's why it's vital that bereavement care is made visible, accessible, and free from stigma.

At MuchLoved, we see every online tribute not only as a space to remember and share, but also as providing access to emotional support. From lighting a candle or sharing a story, to accessing live bereavement counselling through services like GriefChat.

As Catherine Betley, grief counsellor and Head of Charity at MuchLoved, says:

"It's normal for bereaved people to feel the impact of grief for months or even years. But when grief becomes prolonged and overwhelming, we must ensure support is available - not just for emotional wellbeing, but for long-term health."

The Role of Grief Education

This study also highlights the need for more grief-literate communities, such as:

- Healthcare professionals better trained to spot prolonged grief
- Employers who understand the impact of bereavement on staff
- Schools and workplaces that create space for open conversation
- Families and friends who know how to offer real support

The good news? Grief education in the UK is evolving. Public campaigns, workplace initiatives, and digital platforms are all helping people understand that grief is not linear, and that support may be needed long after the funeral has passed.



What We Can All Do to Support People Close to Us Who Are Bereaved

Connection with family, friends and community matters a great deal for bereaved people. Feeling that their loss is acknowledged and that they have the support of family and friends can make all the difference. There are some simple things we can all do to show we care:

- Understand that grief takes time, and that sometimes it can be too much to handle alone
- Offer the bereaved person opportunities to remember, express how they feel and connect with others who may be sharing the same experience
- Continue to talk about their grief and the person they have lost, even if we might prefer to shy away from it



A Final Thought

It's clear that offering access to effective bereavement support is a health imperative. This new research reinforces what many grieving people already know: that love and loss affect the whole self. With the right support, we can help each other carry grief in ways that feel less lonely, and ultimately, more healing.

What Families Really Value


Your feedback also showed some clear themes about what matters most to families:

Of course, the world of funerals is shifting. Direct cremations are on the rise, often driven by cost pressures, and many of us worry this leaves families without the closure they need. At the same time, more families are turning towards celebrations of life, choosing colour, creativity, and alternative locations.

Celebrant-led services, storytelling, and technology, from streaming to slideshows, are fast becoming the norm rather than the exception.

From our findings, we can see that funerals are becoming less about sticking to tradition and more about celebrating each unique life. The challenge, and opportunity, for us all is finding the balance: keeping services affordable while still offering creative, meaningful, and memorable ways to say goodbye.
